Meeting with Dr. Rishi Pal Deputy Excise and Taxation Commissioner

A meeting was held in the Office of The Deputy Excise & Taxation Commissioner, Ludhiana on 24th July, 2013 under the Chairmanship of Dr. Rishi Pal, DETC, Mr. H.P.S Ghotra, AETC, Ludhiana was also present in the meeting.

Following was the agenda of the meeting:

- All Industrial Associations unanimously stressed upon suspending the implementation of E-TRIP till it is properly established mistake-proof and user's friendly. Industries also informed the Tax Officials about various shortcomings in the E-TRIP.
- Checking of goods by Sales Tax Officials on road was also one of the issues which was discussed. It was suggested that the officials on checking the goods, should disclose their names and designations so that they may be contacted for further proceedings and Industrialists are not to run door-to-door to contact about the impounded goods.
- Refund verification on 4th stage is not possible as assessee cannot have any mechanism to verify the same.
- Time-bar cases should not be fixed. As per Industrial Policy - 2009 VAT Refund should be given within 60 days. It is not being followed-up by the departments.
- Appeal be fixed seniority-wise. Refund should be given seniority-wise, not as per the will of officials.
- Industrial leaders mentioned that they are against the tax-evasion and bogus dealers. They requested to the DETC to take appropriate action.
- Various other issues were also discussed related to simplifying the procedure and to make the departments more tax assesses friendly. Dr. Rishi Pal, DETC assured the members that he will conduct meeting every month to make the system more assesses friendly and thus Industries will not be harassed.
